Sun Exploration & Production Company has scheduled a hearing for February 5, 1986, with the State of New Mexico Conservation. This hearing is to obtain approval to drill an unorthodox location for the referenced well. This well will be a Morrow test.

The New Mexico statewide rules for gas wells state that the well cannot be located closer than 1980 feet to the nearest end boundary nor closer than 330 feet to the quarter quarter section or subdivision inner boundary of the proration unit. This well is located only 600 feet from the nearest end boundary, of our 320 acre proration unit, which classifies this as an unorthodox location.

Attached for your information is a copy of the C-102 surveyor plat, showing the proration unit and also an area plat. If you have any questions concerning the above information please contact me at (915) 683-0374.

If you as an offset operator, to our 320 acre proration unit, have no objection to this application, it would be appreciated if you would so indicate by signing below and returning two copies to this office in the enclosed envelope. Your early consideration will be appreciated.
