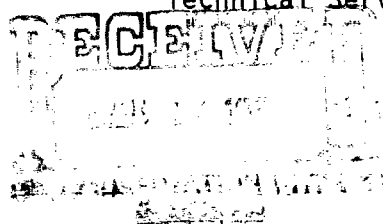

Gentlemen:

Mobil Producing Texas & New Mexico, Inc. (MPTM), is applying for authority to drill the subject wells at an unorthodox location under the provisions of Rule 104 (F). The wells are located closer than 330 feet from the quarter-quarter line but more than 330 feet from the lease line. These wells will be completed in the Vacuum (Grayburg-San Andres) Pool, which is a secondary recovery project.

In order to develop a 20-acre spacing program, these wells are needed at these locations to improve the recovery pattern and recover hydrocarbons that might otherwise be left in place.

In support of this request, the following items are being submitted in triplicate:

1. Form C-101 - Application for Permit to Drill, Deepen or Plug Back;
2. Form C-102 - Well location and acreage dedication plats;
3. Certified plat showing all well locations and offset operators.

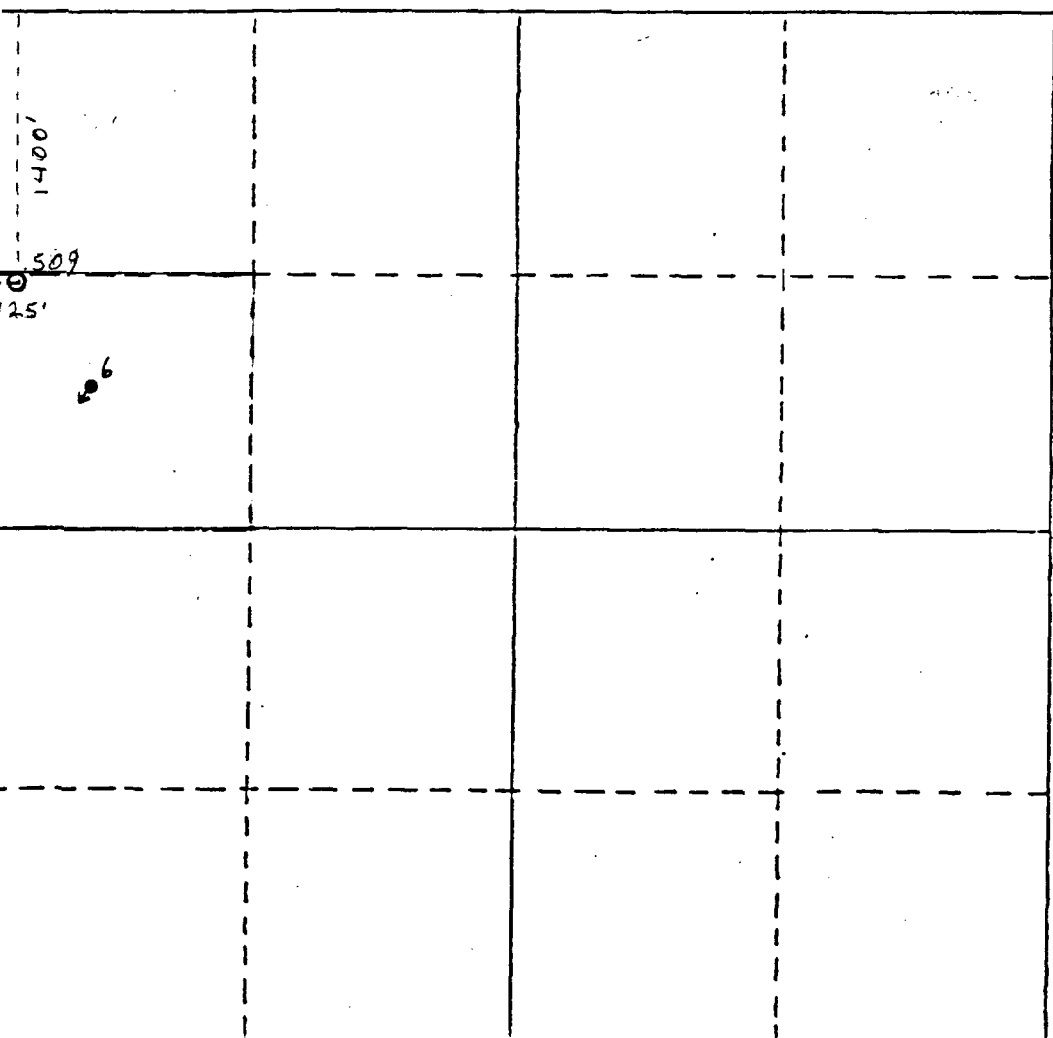




