Gentlemen:

Amoco Production Company respectfully requests that the subject case which is scheduled for an Examiner Hearing on September 17, 1986 be dismissed. Due to the timely application and granting of an emergency hardship classification for this well, large amounts of load fluid which were lost to the formation during a packer repair job have now been recovered such that remaining reserves are no longer at risk upon shutting in the well. This was confirmed by a log-off test conducted from August 13 through August 21, 1986. Based upon the current producing status of this well and the results of the log-off test, continued relief under Division Rule 411 is not required. Gentlemen:

Amoco Production Company respectfully requests that a continuance be granted for the subject cause which is currently docketed for an Examiner hearing on August 6, 1986. The subject well was granted a 90 day emergency hardship gas well classification which expires September 3, 1986. Amoco requests this continuance so that additional data may be gathered during this period to support our case.

Since the granting of the emergency hardship status, Amoco has diligently produced the well in an attempt to clean up formation damage associated with an earlier well repair. To date, the well has not responded, thus a witnessed log-off test in compliance with the hardship gas rule requirements appears to be warranted. We are currently in the process of coordinating this test with the NMOCD District staff and notifying the affected offset operators. Following the test, we intend to monitor the well's ability to return to production following shut-in. With your concurrence we would appreciate a mid to late September hearing date to allow sufficient time to conclude and interpret all the tests.
