





Gentlemen:

In the captioned Order dated August 28, 1986, the Commission ordered the pooling of all mineral interests in the E/2 of Section 23, T25N-R2W, in the Gavilan Mancos and Gavilan Greenhorn-Graneros-Dakota Oil Pools. The well authorized under this Order was to have been commenced not later than November 30, 1986, and by letter dated November 25, 1986, the Order was extended until March 1, 1987.

Mesa Grande Resources, Inc., the designated operator, has been unable to commence a well in the E/2 of Section 23, T25N-R2W because muddy roads and bad weather have prevented the movement of equipment. In addition, not all parties have joined in the Operating Agreement and a second compulsory pooling case has been scheduled.

Therefore, Mesa Grande Resources, Inc. respectfully requests an additional extension of time until August 1, 1987, within which to commence our well.

We will appreciate your consideration in this matter and will look forward to hearing from you soon.
