Re: Request for Consent to Unorthodox Location

Gentlemen:

This firm represents The Long Trusts of Kilgore, Texas, and Phillips Petroleum Company who have entered into a joint venture agreement for the drilling of certain wells in Roosevelt County, New Mexico, to be operated by The Long Trusts.

The Long Trusts and Phillips have proposed the drilling of the Lambirth B No. 3 well, located 900 feet from the North line and 1650 feet from the East line, Section 3, Township 6 South, Range 33 East, N.M.P.M., Roosevelt County, New Mexico. This location places the well in Lot 2 of Section 3, Township 6 South, Range 33 East, which is within the boundaries of the South Peterson-Fusselman Pool, for which the OCD has adopted special rules and regulations. Rule 2 provides that each well shall be located on a standard unit containing 80 acres, and Lots 1 and 2 of Section 3 will be dedicated to the proposed well. Rule 4 provides that each well shall be located within 150 feet of the center of a governmental quarter section or lot. The proposed location is an unorthodox location, being approximately 180 feet east of a point which would constitute an orthodox location.

Rule 5 of the Special Pool Rules provides that the division director may grant an exception to the requirements of Rule 4 without notice and hearing if all offset operators to the proposed location have been notified of the proposed location and have either executed written waivers of protest or filed no objection to the unorthodox location within 20 days of the filing of the application.
