MR. STOGNER: Mr. Taylor.

ROY JOHNSON,

being called as a witness and being duly sworn upon his oath, testified as follows, to-wit:

DIRECT EXAMINATION

BY MR. TAYLOR:

Q Would you please state your name, by whom you're employed and in what capacity?

A My name is Roy Johnson. I'm employed by the New Mexico Oil Conservation Division as Senior Petroleum Geologist.

Q And you're also, are you not, the supervisor for District IV for the Oil Conservation Division?

A I am.

Q And does that district encompass the lands at issue in this case today?

A It does.

Q Mr. -- you've testified before the Commission or its examiners previously, have you not, and had your credentials accepted?

1           A           I have.

2                           MR. TAYLOR: I tender the wit-  
3 ness as an expert, Mr. Examiner.

4                           MR. STOGNER: Mr. Carr, do you  
5 have any objections?

6                           MR. CARR: No objection.

7                           MR. STOGNER: There being none,  
8 Mr. Johnson is so qualified.

9           Q           Mr. Johnson, are you prepared to make  
10 recommendations to the Examiner today concerning the  
11 nomenclature of I guess it's one pool, is it, in Harding and  
12 Union Counties?

13           A           I am.

14           Q           Is your recommendation prepared in the  
15 form of an exhibit?

16           A           It is.

17           Q           And how is that exhibit denominated?

18           A           It is Exhibit One.

19           Q           Exhibit One. Would you please refer to  
20 Exhibit One and to the docket that's been prepared and  
21 distributed at the hearing today and point out any  
22 difference between the two?

23           A           There are no differences.

24           Q           And just, I guess, also for the record,  
25 would you just state the reason for the hearing on this

1 matter?

2           A           On June 10th permanent pool rules were  
3 established in Union, Harding, and Quay Counties in the  
4 Bravo Dome Unit and the area encompassing the subscribed  
5 lands on the docket are those areas that have been producing  
6 for the past three years.

7           Q           Is it my understanding that these produc-  
8 ing areas have just not been officially named? Is that what  
9 we're doing here today --

10          A           Correct.

11          Q           -- is just giving them their name?

12          A           That's correct.

13          Q           Okay, and the docket correctly describes  
14 the land encompassed in the pool?

15          A           Yes, sir.

16          Q           Okay. Do you have anything further to  
17 add to your testimony?

18          A           I do not.

19          Q           And was Exhibit One either prepared by  
20 you or under your supervision and control or have you exa-  
21 mined it and can testify as to its accuracy?

22          A           Yes on all accounts.

23                           MR. TAYLOR: I'll move the ad-  
24 mission of Exhibit One.

25                           MR. STOGNER: If there are no

1 objections, Exhibit One will be admitted into evidence.

2 Mr. Carr, your witness.

CROSS EXAMINATION

5 BY MR. CARR:

6 Q Mr. Johnson, just to be sure I understand  
7 this, there's no intention on the part of the Division by  
8 filing this case to change the Bravo Dome 640-acre spacing  
9 area or the rules that have been promulgated by Order R-  
10 7556, is that right?

11 A That is correct.

12 Q And you're just defining the area that is  
13 now connected and producing.

14 A That's correct.

15 MR. CARR: That's all I have.

16 MR. TAYLOR: And that's all I  
17 have, too.

18 MR. STOGNER: Okay, Mr.  
19 Johnson, in the parentheses we have 640 acre and that  
20 relates back to Mr. Carr's question, that this isn't a pool  
21 or an area that is being developed on 640-acre spacing, is  
22 that correct?

23 A That is correct.

24 MR. STOGNER: If there are no  
25 other questions of Mr. Johnson, he may be excused.

1 Mr. Carr, do you have anything  
2 further?

3 MR. CARR: Nothing further.

4 MR. STOGNER: Mr. Taylor, do  
5 you have anything further in Case Number 9196?

6 MR. TAYLOR: No, sir.

7 MR. STOGNER: Case Number 9196  
8 will be taken under advisement.
