This letter is to serve as application for a non-standard proration unit combining Units D and E (lots 8 & 9) consisting of 56.19 acres, more or less. Due to variations in the legal subdivision of the U.S. Public Land Surveys along the New Mexico - Texas state line a standard proration unit is not available for Unit E (Lot 9).


The Stateline Federal #1 currently has an allowable of 17 barrels per day and is producing an average of 16 barrels per day. The Stateline Federal #2 (see NSL-2450) initial potential is 215 barrels of oil, 278 MCF of gas, and 157 barrels of water per day. The combined acreage can support 150 barrels per day which is the prorated equivalent to the Pool top allowable of 107 barrels per day for 40 acres [(107/40) X 56.19].

This application is being submitted in triplicate. Copies of the letters sent to the offset operators and copies of the proof of receipt are also enclosed. Series 1200 rules were included with the letters to the offset operators.


