



APPLICATION

TEXACO PRODUCING, INC., through its counsel, applies for an order amending special pool rules for the West Jal Strawn Gas Pool providing for 320 acre spacing or proration units. In support, applicant states:

1. On March 1, 1963, the Division entered Order No. R-2439 promulgating temporary special rules for the West Jal Strawn gas pool, including a provision for 640 acre spacing. Order R-2439 was later made permanent by Order No. R-2439-A and was extended to cover lands in Sections 8, 17 and 20, T-25-S, R-36-E, NMPM, Lea County, New Mexico.

2. The Applicant owns or operates certain lands in the West Jal Strawn gas pool, including the E/2 of Section 17, T-25-S, R-36-E, NMPM.

3. Applicant proposes inter alia to re-enter its West Jal B Deep #1 Well located 1980 feet from the North line and 660 feet from the East line and recomplete said well in the Strawn formation.

4. In order to more efficiently and effectively recover the hydrocarbon reserves from the above-referenced lands and to otherwise prevent waste and protect correlative rights, the special pool rules for the West Jal Strawn gas pool should be amended to provide for 320 acre spacing.

WHEREFORE, Applicant requests that this matter be set for hearing before a duly appointed Examiner of the Oil Conservation Division on May 24, 1989, and that notice be given as required by law and the rules of the Division and that the application be approved.
