Dear Mr. Stogner:

BTA hereby requests the above referenced unorthodox location be set for hearing on December 5, 1991. This is the same application previously filed in the Carlsbad, South Morrow field. We are refiling in the White City, Penn due to your letter dated October 17, 1991.

A standard location for the White City (Penn) Field would be 1,650' FEL and 1,650' FSL. This location has been rejected by the BLM because of topographic reasons. The nearest standup location to the north the BLM will approve is 1,900' FSL and 1,650' FEL. The nearest location to the south the BLM will approve is 1,350' FSL and 1,650' FEL. An alternate location of 1,150' FSL and 1,650' FEL is being requested by BTA as a better location geologically.

The objective formation of the 9105 JV-P Crystal #1 is the Morrow sands which produce immediately south in the White City field and immediately northeast in the Carlsbad South field. Both of these fields have been described (R.R. Casavant, 1986) as combination structural-stratigraphic traps with a "significant structural overprint". The proposed location is situated on the north end of a structural nose which trends NNE from the White City field (see enclosed structure map). Northeast and downdip of the proposed location, the C&K Petroleum Allied Chemical Federal #2 tested water from a lower Morrow sand. South and updip, Ultramar Pennzoil Federal #1 and #2 encountered all Morrow sands above water. The proposed location is believed to have a better chance to encounter all the Morrow sands above water.
