


Gentlemen:

This letter is to advise you that Blackwood & Nichols Co. a Limited Partnership has filed an application with the New Mexico Oil Conservation Division seeking approval of an unorthodox gas well location in the Fruitland Coal formation 975 feet from the North line and 1935 feet from the West line of Section 21, Township 30 North, Range 7 West, N.M.P.M., Rio Arriba County, New Mexico.

This application has been set for hearing before an Examiner of the Oil Conservation Division on April 2, 1992. You are not required to attend this hearing, but as an owner of an interest that may be affected by the unorthodox well location, you may appear and present testimony. Failure to appear at that time and become a party of record will preclude you from challenging the matter at a later date.

Parties appearing in cases have been requested by the Division (Memorandum 2-90) to file a Prehearing Statement substantially in the form prescribed by the Division. Prehearing statements should be filed by 4:00 o'clock p.m. on the Friday before a scheduled hearing.
