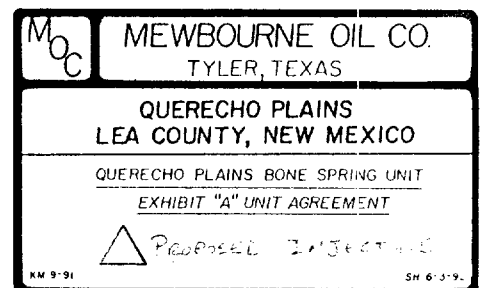



Mewbourne Oil Company requests a one time continuation of water injection into the Government K #2 and Federal E #11 wells located in Sections 23 & 27, T18S, R32E of Lea County. Injectivity into these wells has been better than expected and while potential participants negotiate final unit agreements, Mewbourne feels it prudent to continue injection to check for response in offset producers. To date, all of the injection fluids have stayed contained to the zone of interest.






