

1           WHEREUPON, the following proceedings were had at  
2   9:03 a.m.:

3           CHAIRMAN LEMAY: The meeting will now come to  
4   order.

5           This is the Oil Conservation Commission. My name  
6   is Bill LeMay, I'm Chairman of the Oil Conservation  
7   Commission.

8           To my left is Commissioner Bill Weiss; to my  
9   right, Commissioner Jami Bailey representing the  
10   Commissioner of Public Lands, State of New Mexico.

11           We shall now call the first case on the docket,  
12   which is Case 10,907, which is called by the Oil  
13   Conservation Division to Amend Rules 1111, 1112 and 1115 of  
14   the General Rules and Regulations, providing for the filing  
15   of Forms C-111, C-112 and C-115, respectively, on the last  
16   business day of the month following the month of  
17   production, and for the imposition of penalties for failure  
18   to file timely and accurately.

19           Appearances in Case 10,907?

20           MR. RAND CARROLL: Mr. Chairman, my name is Rand  
21   Carroll, and I'm appearing on behalf of the New Mexico Oil  
22   Conservation Division.

23           CHAIRMAN LEMAY: Are there additional appearances  
24   in Case 10,907?

25           MR. CARROLL: Mr. Chairman --

1           CHAIRMAN LEMAY:  If not -- Go ahead.

2           MR. CARROLL:  Mr. Chairman, the Division asks for  
3 a continuance of six months in this case, due to the  
4 difficulties the Division is experiencing with  
5 implementation of the ONGARD system.

6           The Division is not asking to make these rules  
7 permanent; we are only asking that -- for the continuance  
8 because of the ONGARD problems, and after ONGARD is worked  
9 out, we will then decide whether we will make these rules  
10 permanent or not.

11          CHAIRMAN LEMAY:  Is there any objection to the  
12 continuance of Case 10,907 until six months, with the  
13 interim rules being effective until that time?

14                   (Off the record)

15          CHAIRMAN LEMAY:  Okay, we'll rule from the bench  
16 on this, and there will be six months' continuance of Case  
17 10,907 to either implement these rules permanently or have  
18 them changed.  Meanwhile, the current rules that have been  
19 in effect the last six months, concerning the C-111, C-112  
20 and C-115 will be implemented for the six-month period.

21                   Thank you, Mr. Carroll.

22          MR. CARROLL:  Thank you, Mr. Chairman.

23                   (Thereupon, these proceedings were concluded at
