

APPLICATION

MEWBOURNE OIL COMPANY ("Mewbourne"), through its undersigned attorneys, hereby makes application to the Oil Conservation Division pursuant to the provisions of N.M. Stat. Ann. § 70-2-17, (1978) for an order pooling all mineral interests in the W/2 for all formations developed on 320-acre spacing, the NW/4 for all formations developed on 160-acre spacing, the W/2 NW/4 for all formations developed on 80-acre spacing, and the SW/4 NW/4 for all formations developed on 40-acre spacing of Section 21 Township 18 South, Range 28 East, N.M.P.M., Eddy County, New Mexico, and in support thereof states:

1. Mewbourne owns or represents approximately 67% of the working interest in the W/2 of Section Section 21, and Mewbourne has the right to drill thereon.
2. Mewbourne proposes to drill its CHALK BLUFF DRAW PROSPECT ILLINOIS CAMP "21" STATE NO. 1 WELL at a standard location 1980 feet from the North line and 660 feet from the West line of Section 21, and drill to a depth of approximately 10,700 feet, more or less, to test any and all formations from the base of the San Andres formation to the base of the Morrow formation, North Illinois Camp-Morrow Gas Pool.
3. Mewbourne has sought and been able to obtain either a voluntary agreement for pooling or farmout from certain interest owners in the W/2 of said Section 21.


4. Said pooling of interests will avoid the drilling of unnecessary wells, will prevent waste and will protect correlative rights.

5. In order to permit Mewbourne to obtain its just and fair share of the oil and gas underlying the subject lands, all mineral interests should be pooled, and Mewbourne should be designated the operator of the well to be drilled.

WHEREFORE, Mewbourne Oil Company requests that this application be set for hearing before a duly appointed Examiner of the Oil Conservation Division on March 17, 1994, and, after notice and hearing as required by law, the Division enter its order pooling the lands, including provisions designating Mewbourne Oil Company operator of the well and spacing unit, authorizing Mewbourne to recover its costs of supervision while drilling and after completion, including overhead charges, and imposing a risk factor for the risk assumed by Mewbourne in drilling, completing and equipping the well.
