3 8323, application of Blanco Engineering, Inc., for salt  
4 water disposal, Eddy County, New Mexico.

5 MR. CARR: May it please the  
6 Commission, Blanco Engineering, Inc. and Yates Petroleum  
7 Corporation have entered a stipulation whereby this case may  
8 be dismissed and that stipulation should be offered into the  
9 record of the case.

11 Petroleum Corporation waives any claims it has against Blan-  
12 co for any activity on the subject well, and with your -- if  
13 there is no objection, I would offer the stipulation. I

18 We have entered into a stipula-  
19 tion with Yates Petroleum and ask that it be incorporated as  
20 part of the record in this case.

21 MR. STAMETS: Okay, the stipu-  
22 lation will be accepted for the record and I presume all the  
23 parties seek dismissal of this case, is that correct?

24 MS. AUBREY: That's correct.

25 MR. STAMETS: Case 8323 will be
