

A P P L I C A T I O N

COMES NOW, Phillips Oil Company, by and through its attorneys, Kellahin & Kellahin, and apply to the New Mexico Oil Conservation Division for approval of an unorthodox oil well location 1300 feet from the North line and 1500 feet from the East line of Section 24, T17S, R29E, NMPM, Eddy County, New Mexico, and in support thereof would show:

1. Applicant has the right to drill and develop the NW/4NE/4 of Section 24, T17S, R29E, Eddy County, New Mexico.
2. Applicant proposes to drill its Keely-A Federal Well No. 29 at an unorthodox oil well location 1300 feet from the North line and 1500 feet from the East line of Section 24, T17S, R29E, NMPM.
3. Applicant proposes to dedicate the NW/4NE/4 of said Section 24 to the well.

4. The proposed unorthodox well location is necessary to permit the completion of an efficient production and injection pattern within a cooperative secondary recovery project.

WHEREFORE, applicant requests that this matter be set for hearing and that after notice and hearing the application be granted as requested.
