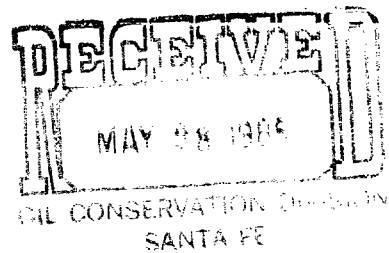

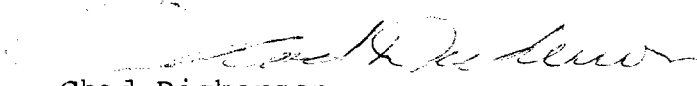

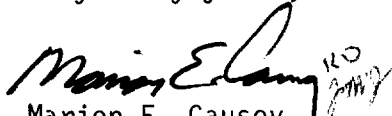

Mesa Petroleum Co is in receipt of a letter from TXO Production Corp. dated May 23, 1985, requesting a waiver from Mesa of any objection to TXO's proposed location for the captioned well (660' FWL and 660' FSL of Section 36, T-24-S, R-26-E, Eddy County, New Mexico - 11,700' Morrow Test).

Please be advised that Mesa Petroleum Co., as operator of the Moore Federal Com. #1 well and the Moore Federal Com. #1E well, both in Section 35, T-24-S, R-26-E, Eddy County, New Mexico, both producing from the White City Penn. field, does object to TXO's proposed location on the grounds that a 11,700' Morrow Test at the said location is crowding the section line and boundry of White City Penn. Field and that our leases would suffer unfair drainage from said location. White City Penn Field rules call for location 1650' from boundry lines.

Mesa, by this letter requests that the New Mexico Oil Conservation Division grant a Continuance in order that Mesa have time to properly prepare for the hearing.
