

In accordance with a request from your office, I wish to clarify the confusion about the above referenced cases.

I have never received a copy of the Order R-8135 and was under the mistaken impression that the forced pooling order R-8136 dealt with the Sprinkle #3 Well. I realized today, for the first time, that orders had been entered in both cases.

It is my intention to seek a stay of both forced pooling orders and to request a DeNovo hearing in both cases.

Accordingly, please find enclosed our request for DeNovo hearings in both cases. Further, please amend my request for a stay which we filed on February 10, 1986, to include a stay of both orders.

In both cases, TXO is trying to force Mr. Sprinkle to make his thirty day election based upon the Examiner orders and not under the final Commission orders to be entered in the respective cases.
