APPLICATION

Amerind Oil Company hereby makes application for pool creation and special pool rules in connection with certain Lea County, New Mexico lands as follows:

1. Applicant seeks the creation of a new Strawn Oil Pool for its Shipp No. 1 Well located 660 feet from the north line and 1,980 feet from the east line of Section 33, Township 16 South, Range 37 East, N.M.P.M., Lea County, New Mexico and special rules therefor including 80 acre oil well spacing and a provision for wells to be located in either quarter-quarter section of the 80 acres dedicated to the well and not closer than 330 feet from the boundary of a governmental quarter-quarter section.

2. Said proposed new Strawn Oil Pool was discovered by the Shipp No. 1 Well located in the NW $\frac{1}{4}$ NE $\frac{1}{4}$  Section 33, Township 16 South, Range 37 East, N.M.P.M., Lea County, New Mexico. Said well has been completed in the Strawn Formation with producing intervals between 11,259 feet and 11,322 feet from the surface. Said well is located within a 1 mile radius of a well located in the Casey Strawn Pool and also within a 1 mile radius of a well located in the Lovington Northeast Pennsylvanian Pool. Accordingly at this time, in line with New Mexico Oil Conservation Division regulations and without creation of a new

Strawn pool for said well, it could be classified as a development well from either the Casey Strawn Pool or the Lovington Northeast Pennsylvanian Pool. However, pursuant to geological data assembled by the Applicant, Applicant is able to show that Applicant's Shipp No. 1 Well is producing from a separate pool and accordingly the Division should authorize the creation of a new Strawn oil pool and special rules, as requested by the Applicant.

3. The horizontal limits of the new pool, as the same are identifiable at this time, should consist of the following described area:

Township 16 South, Range 37 East, N.M.P.M.


Section 33: W $\frac{1}{2}$ NE $\frac{1}{4}$
