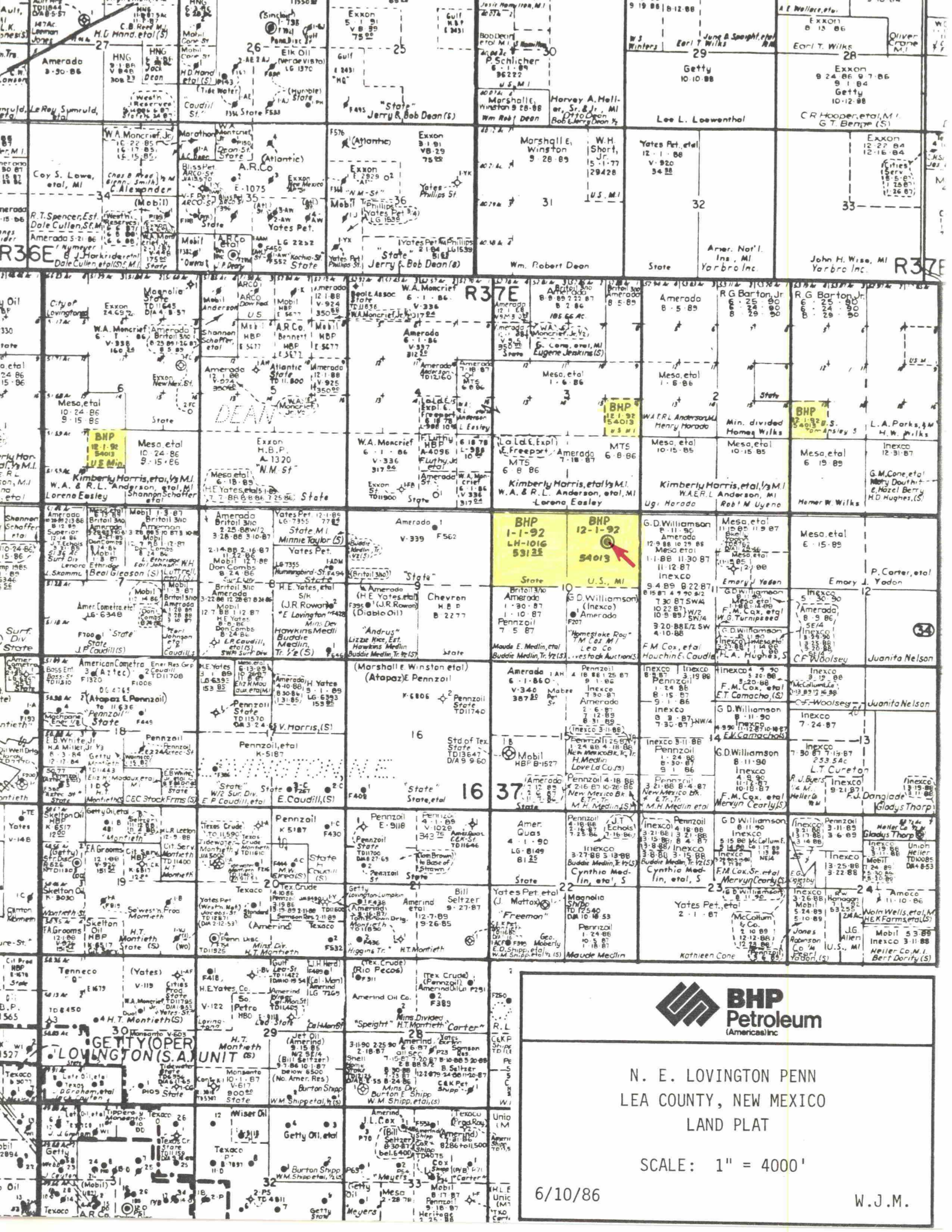




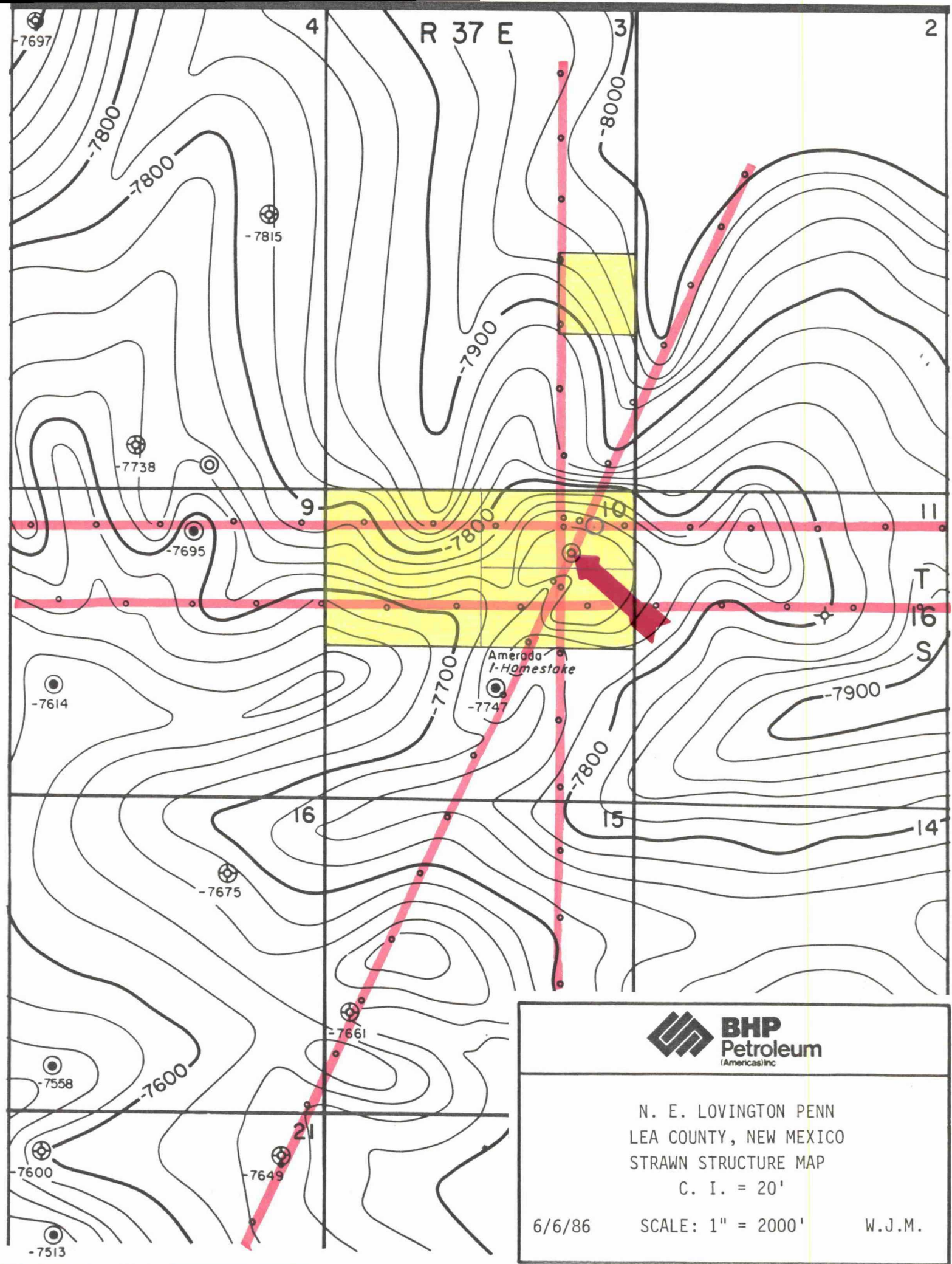
N. E. LOVINGTON PENN

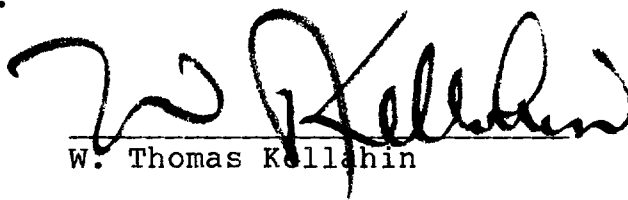

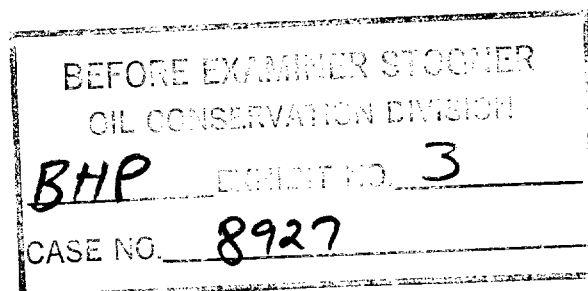
