

A P P L I C A T I O N

COMES NOW PHILLIPS PETROLEUM COMPANY, by and through its attorneys, Kellahin, Kellahin & Aubrey and applies to the New Mexico Oil Conservation Division for the adoption of special rules and regulations for the Cabin Lake Delaware Pool, Eddy County, New Mexico, and in support thereof would show:

1. Applicant is the operator of the discovery well for said pool being the James A. Well No. 2 located in Unit J of Section 2, T22S, R30E, Eddy County, New Mexico.

2. As a result of Nomenclature Case 9149 heard by the Division on June 3, 1987, the Cabin Lake-Delaware Pool was created comprising the SE/4 of said Section 2.

3. The current depth bracket allowable under statewide rules would be 107 barrels of oil per day.

4. Applicant requests that a special allowable of up to 300 barrels of oil per day be established for the pool.

5. The offset operators within one mile of the pool are as shown on Exhibit "A", each of whom has been notified of this application pursuant to Division rules.

6. Production at rates up to 300 barrels of oil per day will allow the pool to be operated at a pressure above the bubble point of the pool and therefore will not result in waste.

WHEREFORE, applicant requests that the subject application be set for hearing and that after notice and hearing the application be granted.


