APPLICATION

COMES NOW, Sun Exploration and Production Company and applies to the Oil Conservation Division of the State of New Mexico for an order amending Order R-6483, dated October 20, 1980, to include its proposed State "A" A/C-2 Well No. 73 in the 640-acre simultaneous dedication presently approved for the State "A" A/C-2 Well Nos. 14, 36, 42 and 62, and for approval of an unorthodox gas well location, 990 FSL and 660 FEL, Section 11, Township 22 South, Range 36 East, Lea County, New Mexico and in support thereof would show the Commission:

1. Applicant has the right to drill and develop the acreage to be dedicated to this well.
2. Applicant proposes to drill its State "A" A/C-2 No. 73 well at an unorthodox gas well location 990 FSL and 660 FEL, Section 11, T22S, R36E, Lea County, New Mexico.

3. Applicant proposes to dedicate Section 11, T22S, R36E, to said well.

4. Applicant proposes to attempt a completion in the Jalmat Gas Pool - Yates Seven Rivers Formation.

5. In the event that said well is completed as an oil well, it will be located at a standard oil well location.

6. In the event that said well is completed as an oil well, Applicant proposes to dedicate a standard 40-acre proration unit comprising the SE/4 of the SE/4, Section 11, T22S, R36E, to said well.

WHEREFORE, Applicant requests that this matter be set for hearing on December 16, 1987, and that, after notice and hearing, the Application be granted as requested.


