



In accordance with the incorrect instructions contained in the McKay Oil Corporation (MOC) letter to "All Interested Parties - Camp State Unit Area" I am writing to you to oppose both the Camp State Unit and the West Fork Unit, on behalf of myself and Bigar Energy Corporation. Although you informed me that I would have to be present, with counsel, in order to oppose the formation of these units, that is now logistically impossible. Had the MOC letter not been incorrect, perhaps intentionally so, I would have had adequate time to adjust my schedule as well as that of my attorney in order to be present. At the time of receipt of the MOC letter, I was in Switzerland and I had my secretary read the contents to me. As their letter indicated that the unit(s) could be opposed in writing, I felt that I was under no time pressure and would be able to handle this matter, by mail, upon my return.

The proposed formation of both the Camp State Unit and the West Fork Federal Unit seems to be motivated by MOC's lack of adherence to the drilling obligation of their leases destined to be contained within these units. MOC has been aware of the necessity of drilling a well to hold each State of New Mexico Lease, since the acquisition of these leases, almost ten years ago. Both Bigar Energy Corporation and I have lost rights to leases for the same failure to drill but, at no time did we attempt to circumvent the intent of these leases by attempting to form a State Unit.

Apparently, the only reason for MOC's attempt to form a State Unit, is monetary. MOC is aware that the value of the acreage to be contained in the proposed units is far greater than the lease bonus paid. If MOC is allowed to form these units, the only group to benefit would be MOC itself. This profit is clearly to be taken out of the pockets of the State of New Mexico.

Not only has MOC tried to profit, itself, to the detriment of the State of New Mexico, MOC is trying to profit by offering an exceptionally unfavorable deal to those who are asked to join. MOC is asking that potential participants dilute their interests by the high level of overrides already assigned from the MOC acreage, some of it to MOC itself. This is clearly neither fair nor just. Also, MOC is planning to re-enter a well on the Camp State Unit in which MOC paid only a percentage of drilling costs and to bill other participants for money never expended by MOC.


Current day, somewhat depressed, pricing is clearly not a cause for MOC to benefit by continuing to hold drilling rights on the subject acreage. Obviously the return on investment within the current market parameters has been sufficient to motivate MOC and Yates Petroleum to drill many wells. According to our records MOC and Yates have drilled over 100 wells during the past 2 years with similar gas prices.

In short, MOC's proposal for formation of both the Camp State Unit and the West Fork Federal Unit must not be approved for the following reasons:

1. MOC incorrectly notified interested parties, perhaps with the intent of lessening potential opposition. Bigar Energy Corporation would certainly have had a representative(s) present had it been notified correctly. This lack of adherence, alone, should be sufficient to either deny or delay all proceedings. If the notification was intentionally incorrect, appropriate disciplinary action should be undertaken. MOC's mis-notification, if tolerated, will result in the abrogation of certain rights of opposition for affected parties.
2. There is no clear justification for the formation of either unit aside from avarice (at the expense of the State of New Mexico and other parties). Joining either unit would result in a biased and unfair dilution of participants' interest.
3. Approval of either unit would deny all interested parties the opportunity to again bid for the subject leases in a competitive environment. MOC has had more than ample opportunity to develop these leases and has failed to do so in spite of the more than ample rate of return yielded even at the semi-depressed current day pricing structure.

I appreciate being able to make my thoughts and my opposition a part of the record for these proceedings and I hope that the benefits to the people of the State of New Mexico are not permitted to take a back seat to the business interests of McKay Oil Corporation.







A review of the Camp State Unit agreement reveals that this unit was approved effective June 29, 1988. The unit area contains 5,453.34 acres which were being held by the successful completion of the Camp State Unit Well No. 1-J, Section 25, Township 5 South, Range 22 East, Chaves County, New Mexico. This well is located on State Lease No. LG-5563-3.

Our records also reflect the following:

1. The Camp State Unit Well No. 1 was completed and shut-in on August 22, 1988 in the Abo formation. Current NMOCD well reports reflect that this gas well is dedicated to a 160.00 acre proration unit consisting of the SE $\frac{1}{4}$ of Section 25-5S-22E.
2. By your letter of February 8, 1989, you determined that the Camp State Unit Well No. 1 was a commercial well in the Abo formation.
3. Our letter of February 15, 1989, concurred with your determination that the Camp State Unit Well No. 1 was a commercial producer.
4. No other wells have been drilled by McKay Oil Corporation within the unit area.
5. As of this date the Camp State Unit Well No. 1 remains shut-in.
6. Our records reveal that the last shut-in royalty payment received was paid on Lease No. LG-5563-3. This shut-in payment was received on January 24, 1990, and was applied for the period of July 1, 1990 to July 1, 1991.

7. As of this date, no other shut-in royalty payments have been received for either LG-5563 or any other lease committed to this agreement.
8. Pursuant to Article 9 of the Camp State Unit Agreement, all undeveloped regular well spacing or proration unit tracts within the unit boundaries were automatically eliminated from the unit agreement effective June 29, 1993.
9. Because of the strict segregation clause in the Camp State Unit, the unit's remaining acreage is on Lease No. LG-5563-3, being the pro-ration unit location of your initial well, and is described as the SE $\frac{1}{4}$ of Section 25-5S-22E containing 160.00 Acres.


In addition to the above, Article 17. Effective Date and Term, of the unit agreement provides for the unit agreement to remain in effect for 5 years after approval of said unit and to remain in effect "so long as unitized substances are being produced in paying quantities from the unitized land . . ." Since the Camp State Unit Well No. 1 is currently not producing and no recent shut-in royalty payments have been paid on any leases committed to the unit, the Camp State Unit Agreement is no longer in effect and all leases committed to this agreement including LG-5563 have been expired effective June 29, 1993.
