In accordance with our telephone conference today regarding the application of Robert L. Bayless for a de novo hearing, I am submitting this letter in lieu of a formal Pre-Hearing Statement.

This case involves the application of Robert L. Bayless for downhole commingling, Rio Arriba County, New Mexico, which was heard by the Oil Conservation Division on September 23, 1993. The application was denied pursuant to Division Order No. R-10008 issued on November 2, 1993.

Kevin H. McCord, a consulting petroleum engineer in Farmington, New Mexico will testify on behalf of Bayless at the de novo hearing. Mr. McCord's testimony will be based on several exhibits including lease ownership plat, one point back pressure tests for the Gallup and Pictured Cliffs formations, summary of gas analysis, allocation formula, and administrative application. I anticipate that Mr. McCord's testimony will take twenty to thirty (20-30) minutes.
