In behalf of Texas Pacific Oil Company, Inc., it is requested that the subject unit be included on the May 8, 1974, schedule for a hearing to approve same.


This unit, as outlined on the attached plat, covers 8,465.21 acres and is being formed for exploratory purposes. The character of ownership is as follows:
