COMES NOW Yates Petroleum Corporation, by its attorneys, and in support hereof, respectfully states:

1. Applicant is the operator of the following lands in Chaves County, New Mexico:

containing 46,080 acres, more or less.

2. The Applicant seeks to commit the above described lands to an exploratory unit known as the Blackwater Unit. The unit consists of federal and state lands.

3. The ratification or approval of all leasehold owners, including the State of New Mexico, required to ratify such unit agreement will be forthcoming prior to the effective date of any order issued pursuant to this Application by the Division.

B. That upon hearing, the Division enter its order approving the Blackwater Unit Agreement, with Applicant as operator, as an exploratory unit embracing the above described lands.
