**IN THE MATTER OF CASE NO. 13243 BEING REOPENED PURSUANT TO
THE PROVISIONS OF DIVISION ORDER NO. R-12134, WHICH ORDER
ESTABLISHED TEMPORARY SPECIAL POOL RULES FOR THE YOUNG-
STRAWN POOL IN LEA COUNTY, NEW MEXICO, INCLUDING PROVISIONS
FOR 80-ACRE SPACING AND PRORATION UNITS AND DESIGNATED WELL
LOCATION REQUIREMENTS.**

ORDER OF THE DIVISION

BY THE DIVISION:

This case came on for hearing at 8:15 a.m. on November 3, 2005, at Santa Fe, New Mexico, before Examiner David R. Catanach.

NOW, on this 22nd day of November, 2005, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner,

FINDS THAT:

- (1) Due public notice has been given, and the Division has jurisdiction of this case and its subject matter.
- (2) Division Cases No. 13242 and 13243 were consolidated at the hearing for the purpose of testimony.
- (3) By Order No. R-12134 issued in Case No. 13243 on April 23, 2004, the Division, upon application of Mewbourne Oil Company, established temporary special pool rules for the Young-Strawn Pool, Lea County, New Mexico, including provisions for 80-acre spacing and proration units and designated well location requirements such that wells shall be located no closer than 330 feet to the outer boundary of the spacing unit, nor closer than 330 feet to any quarter-quarter section line or subdivision inner boundary.

(4) Pursuant to the provisions of Order No. R-12134, this case was reopened to allow the operators in the subject pool to appear and show cause why the "*Temporary Special Pool Rules for the Young-Strawn Pool*" should not be rescinded and the pool developed on statewide 40-acre spacing.

(5) The Young-Strawn Pool currently comprises the E/2 of Section 17, and the NE/4 of Section 20, both in Township 18 South, Range 32 East, NMPM, Lea County, New Mexico.

(6) Mewbourne Oil Company ("Mewbourne") appeared at the hearing and presented evidence to support the permanent adoption of the special pool rules for the Young-Strawn Pool.

(7) Mewbourne presented evidence that demonstrates that:

- (a) there are currently three wells producing within the Young-Strawn Pool. These are the Mewbourne SF "17" Federal Com Well No. 1 (API No. 30-025-36345) located in Unit G of Section 17, the Mewbourne SF "17" Federal Com Well No. 2 (API No. 30-025-36417) located in Unit J of Section 17, and the Chesapeake Operating Inc.'s Young Federal Well No. 1 (API No. 30-025-24940) located in Unit G of Section 20;
- (b) the SF "17" Federal Com Well No. 2 has cumulatively produced 70,877 barrels of oil and 175 MMCF of gas from the Strawn formation and is expected to ultimately recover 108,088 barrels of oil and 450 MMCF of gas from the subject reservoir;
- (c) the Young Federal Well No. 1 has cumulatively produced 105,958 barrels of oil and 207 MMCF of gas from the Strawn formation and is expected to ultimately recover 120,408 barrels of oil and 264 MMCF of gas from the subject reservoir;

- (d) drainage data based upon volumetric and decline curve analysis shows that the SF "17" Federal Com Well No. 2 will ultimately drain an area in excess of 80 acres, and that the Young Federal Well No. 1 will ultimately drain an area of approximately 70 acres.

(8) Testimony by Mewbourne indicates that it is unlikely that additional drilling will occur within the Young-Strawn Pool.

(9) The engineering evidence presented by Mewbourne demonstrates that the current well spacing within the Young-Strawn Pool is appropriate, and that permanent adoption of the special pool rules will prevent waste and protect correlative rights.

(10) No other operator and/or interest owner appeared at the hearing.

(11) The *"Temporary Special Pool Rules for the Young-Strawn Pool"* should remain in full force and effect until further order of the Division.

IT IS THEREFORE ORDERED THAT :

(1) The *"Temporary Special Pool Rules for the Young-Strawn Pool"*, as established by Division Order No. R-12134 dated April 23, 2004, are hereby continued in full force and effect until further order of the Division.

(2) Jurisdiction is hereby retained for the entry of such further orders as the Division may deem necessary.
