ORDER OF THE DIVISION

BY THE DIVISION:

This case came on for hearing at 8:15 a.m. on April 13, 2006, at Santa Fe, New Mexico, before Examiner David K. Brooks.

NOW, on this 28<sup>th</sup> day of April, 2006, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner,

FINDS THAT:

- (1) Due public notice has been given, and the Division has jurisdiction of this case and its subject matter.
- (2) There is need for the contraction of the Blinebry Oil and Gas Pool (**Pool Code Oil** - 6660, Gas - 72480) in Lea County, New Mexico in order to correct nomenclature. The deleted acreage will be placed in the North Eunice-Blinebry-Tubb-Drinkard Pool (**Pool Code** 22900).
- (3) There is need for the contraction of the Drinkard Pool (**Pool Code 19190**) in Lea County, New Mexico in order to correct nomenclature. The deleted acreage will be placed in the North Eunice-Blinebry-Tubb-Drinkard Pool (**Pool Code** 22900).
- (4) There is need for the contraction of the Tubb Oil and Gas Pool (**Pool Code Oil** - 60240, Gas - 86440) in Lea County, New Mexico in order to correct

nomenclature. The deleted acreage will be placed in the North Eunice-Blinebry-Tubb-Drinkard Pool (**Pool Code 22900**).

(5) There is need for extensions to the Blinebry Oil and Gas Pool, the Drinkard Pool, the North Eunice-Blinebry-Tubb-Drinkard Pool, and the Tubb Oil and Gas Pool, all in Lea County, New Mexico.

IT IS THEREFORE ORDERED THAT:

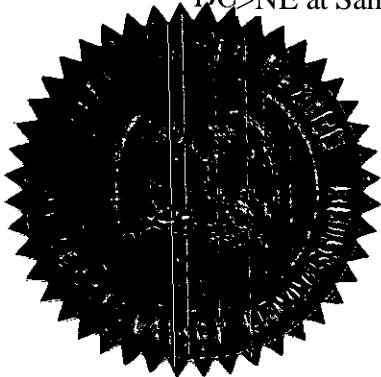
Section 8: W/2 W/2 and SE/4 NW/4

IT IS FURTHER ORDERED THAT:

(1) Pursuant to Section 70-2-18, NMSA, 1978, an operator of any well that, by virtue of any of the above pool extensions, is subject to pool rules providing for spacing or proration units larger than the one presently dedicated thereto, shall have 60 days from the effective date of this order to file Form C-102 dedicating a standard unit for the pool to that well or to obtain a non-standard unit approved by the Division. Pending such compliance, the well shall receive a maximum allowable in the same proportion to a standard allowable for the pool that the acreage dedicated to the well bears to a standard unit for the pool. Failure to file Form C-102 dedicating a standard unit to the well or to obtain a non-standard unit approved by the Division within that 60-day period shall subject the well to cancellation of allowable.

(2) The effective date of this order and all contractions and extensions included herein shall be May 1, 2006.
