Dear Ms. Baker:

This office has received Apache Corporation's letter dated April 19, 2018, requesting final approval for the Thunderbird Development Unit, Eddy County, New Mexico.

The New Mexico State Land Office has this date granted final approval for the Thunderbird Development Unit Agreement. State Land Office approval is subject to like approval by the Bureau of Land Management and the New Mexico Oil Conservation Division.

- The unit agreement becomes effective on May 1, 2018.
- The NM State Land Office has also received Apache's letter dated April 18, 2018, requesting an extension from November 1, 2018, to September 2019 to comply with the Section 9 requirement to submit an initial paying well determination. Section 9 of the unit agreement also allows the AO and Land Commissioner to modify any of the drilling requirements by granting reasonable extensions of time when, in their opinion, such action is warranted. In a letter dated June 13, 2018, the AO granted this extension to September 1, 2019. The State Land Office concurs with the BLM's extension to submit a paying well determination no later than **September 1, 2019**.
- Your filing fee of \$600 has been received.
- Enclosed are five (5) Certificates of Approval.
- Please note the attached checklist to assist in completing the NM State Land Office requirements for this unit.
