APPLICATION OF PETROCAP, INC. FOR COMPULSORY POOLING, ROOSEVELT COUNTY, NEW MEXICO.

ORDER OF THE DIVISION

BY THE DIVISION:

This case came on for hearing at 8:15 a.m. on June 27, 2002, at Santa Fe, New Mexico, before Examiner David K. Brooks.

NOW, on this 6th day of August, 2002, the Division Director, having considered the testimony, the record and the recommendations of the Examiner,

FINDS THAT:

- (1) Due public notice has been given, and the Division has jurisdiction of this case and of the subject matter.
- (2) Petrocap, Inc., ("Applicant"), seeks an order pooling all uncommitted mineral interests from the surface to the base of the Basal Penn Unconformity Sand formation underlying the N/2 of Section 34, Township 4 South, Range 31 East, NMPM, Roosevelt County, New Mexico, in the following manner:

The N/2, forming a standard 320-acre gas spacing and proration unit (the "320-acre Unit") for all formations or pools spaced on 320 acres within this vertical extent.

The NW/4, forming a standard 160-acre gas spacing and proration unit (the "160-acre Unit") for all formations or pools spaced on 160 acres within this vertical extent.

The S/2 NW/4, forming a standard 80-acre spacing and proration unit (the "80-acre Unit") for all formations or pools spaced on 80 acres within this vertical extent.

The SW/4 NW/4, forming a standard 40-acre oil spacing and proration unit (the "40-acre Unit") for all formations or pools spaced on 40 acres within this vertical extent.

- (3) The above-described units (the Units) are to be dedicated to Applicant's McCowen Well No. 1 (proposed re-entry) located at a standard well location within the SW/4 NW/4 (Unit E) of Section 34 (1980 feet from the North line and 660 feet from the West line of said section).
- (4) Two or more separately owned tracts are embraced within each of the Units, and/or there are royalty interests and/or undivided interests in oil and gas minerals in one or more tracts included in each of the Units that are separately owned.
- (5) Applicant is an owner of an oil and gas working interest within each of the Units. Applicant has the right to re-enter and proposes to re-enter the McCowen Well No. 1 (the "well") and to produce the same from a common source of supply within the SW/4 NW/4 of Section 34.
- (6) There are interest owners in each of the Units that have not agreed to pool their interests.
- (7) To avoid the drilling of unnecessary wells, protect correlative rights, prevent waste and afford to the owner of each interest in the Units the opportunity to recover or receive without unnecessary expense its just and fair share of hydrocarbons, this application should be approved by pooling all uncommitted mineral interests, whatever they may be, within the Units.
- (8) Pursuant to the request of Applicant, Kestrel, Inc. should be designated the operator of the proposed well and of the Units.
- (9) Applicant has requested that the risk charge for non-consenting working interest owners be fixed at 200%. Although this case involves reentry of an existing well, Applicant presented testimony to the effect that the well was drilled and abandoned at a very remote time by another operator, that no testing was done of the proposed zone, and that the closest production from the proposed zone is more than 100 miles away.
- (10) Reasonable charges for supervision (combined fixed rates) should be fixed at \$4,772 per month while re-entering and completing and \$523 per month while producing, provided that these rates should be adjusted annually pursuant to Section III.1.A.3. of the COPAS form titled "Accounting Procedure-Joint Operations." The operator should be authorized to withhold from production the proportionate share of

both the supervision charges and the actual expenditures required for operating the well, not in excess of what are reasonable, attributable to each non-consenting working interest.

IT IS THEREFORE ORDERED THAT:

- (1) Pursuant to the application of Petrocap, Inc., all uncommitted mineral interests from the surface to the base of the Basal Penn Unconformity Sand formation underlying the N/2 of Section 34, Township 4 South, Range 31 East, N.M.P.M., Roosevelt County, New Mexico, are hereby pooled, as follows:
 - (a) The N/2, forming a standard 320-acre gas spacing and proration unit for all formations or pools spaced on 320 acres within this vertical extent.
 - (b) The NW/4, forming a standard 160-acre gas spacing and proration unit for all formations or pools spaced on 160 acres within this vertical extent.
 - (c) The S/2 NW/4, forming a standard 80-acre spacing and proration unit for all formations or pools spaced on 80 acres within this vertical extent.
 - (d) The SW/4 NW/4, forming a standard 40-acre oil spacing and proration unit for all formations or pools spaced on 40 acres within this vertical extent.

The Units shall be dedicated to Applicant's McCowen Well No. 1 (proposed reentry) located at a standard well location within the SW/4 NW/4 (Unit E) of Section 34 (1980 feet from the North line and 660 feet from the West line of said section).

- (2) The operator of the Units shall commence re-entry of the well on or before October 31, 2002, and shall thereafter continue operations with due diligence to test the Basal Penn Unconformity Sand formation.
- (3) In the event the operator does not commence re-entry of the proposed well on or before October 31, 2002, Ordering Paragraph (1) shall be of no effect, unless the operator obtains a time extension from the Division Director for good cause.
- (4) Should the well not be completed, or be abandoned, within 120 days after commencement of re-entry, the operator shall appear before the Division Director and show cause why Ordering Paragraph (1) should not be rescinded.

- (5) Pursuant to the request of Applicant, Kestrel, Inc. is hereby designated the operator of the well and of the Units.
- (6) After pooling, uncommitted working interest owners are referred to as non-consenting working interest owners. ("Uncommitted working interest owners" are owners of working interests in the Units, including unleased mineral interests, who are not parties to an operating agreement governing the Units.) After the effective date of this order, the operator shall furnish the Division and each known non-consenting working interest owner in the Units an itemized schedule of estimated well costs of the proposed re-entry and recompletion of the well.
- (7) Within 30 days from the date the schedule of estimated well costs is furnished, any non-consenting working interest owner shall have the right to pay its share of estimated well costs to the operator in lieu of paying its share of reasonable well costs out of production as hereinafter provided, and any such owner who pays its share of estimated well costs as provided above shall remain liable for operating costs but shall not be liable for risk charges.
- (8) The operator shall furnish the Division and each known non-consenting working interest owner an itemized schedule of actual well costs within 90 days following completion of the well. If no objection to the actual well costs is received by the Division, and the Division has not objected within 45 days following receipt of the schedule, the actual well costs shall be deemed to be the reasonable well costs. If there is an objection to actual well costs within the 45-day period, the Division will determine reasonable well costs after notice and hearing.
- (9) Within 60 days following determination of reasonable well costs, any non-consenting working interest owner who has paid its share of estimated costs in advance as provided above shall pay to the operator its share of the amount that reasonable well costs exceed estimated well costs and shall receive from the operator its share of the amount that paid, estimated well costs exceed reasonable well costs.
- (10) The operator is hereby authorized to withhold the following costs and charges from production:
 - (a) the proportionate share of reasonable well costs attributable to each non-consenting working interest owner who has not paid its share of estimated well costs within 30 days from the date the schedule of estimated well costs is furnished; and

- (b) as a charge for the risk involved in re-entering and attempting to complete the well, 200% of the above costs
- (11) The operator shall distribute the costs and charges withheld from production, proportionately, to the parties who advanced the well costs.
- (12) Reasonable charges for supervision (combined fixed rates) are hereby fixed at \$4,772 per month while re-entering and completing and \$523 per month while producing, provided that these rates shall be adjusted annually pursuant to Section III.1.A.3. of the COPAS form titled "Accounting Procedure-Joint Operations." The operator is authorized to withhold from production the proportionate share of both the supervision charges and the actual expenditures required for operating the well, not in excess of what are reasonable, attributable to each non-consenting working interest.
- (13) Except as provided in Ordering Paragraphs (10) and (12) above, all proceeds from production from the well that are not disbursed for any reason shall be placed in escrow in Roosevelt County, New Mexico, to be paid to the true owner thereof upon demand and proof of ownership. The operator shall notify the Division of the name and address of the escrow agent within 30 days from the date of first deposit with the escrow agent.
- (14) Any unleased mineral interest shall be considered a seven-eighths (7/8) working interest and a one-eighth (1/8) royalty interest for the purpose of allocating costs and charges under this order. Any well costs or charges that are to be paid out of production shall be withheld only from the working interests' share of production, and no costs or charges shall be withheld from production attributable to royalty interests.
- (15) Should all the parties to this compulsory pooling order reach voluntary agreement subsequent to entry of this order, this order shall thereafter be of no further effect.
- (16) The operator of the well and Units shall notify the Division in writing of the subsequent voluntary agreement of all parties subject to the forced pooling provisions of this order.
 - (17) Jurisdiction of this case is retained for the entry of such further orders as

the Division may deem necessary.
