THE APPLICATION OF THE OIL CONSERVATION DIVISION FOR AN ORDER CREATING AND EXTENDING CERTAIN POOLS IN CHAVES AND EDDY COUNTIES, NEW MEXICO.

#### ORDER OF THE DIVISION

#### BY THE DIVISION:

This case came on for hearing at 8:15 a.m. on March 1, 2007, at Santa Fe, New Mexico, before Examiner Richard I, Ezeanyim.

NOW, on this 6<sup>th</sup> day of March, 2007, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner,

#### **FINDS THAT:**

- (1) Due public notice has been given, and the Division has jurisdiction of this case and its subject matter.
- (2) There is need for the creation of a new pool in Eddy County, New Mexico for the production of gas from the Bone Spring formation, bearing the designation of Golden Lane-Bone Spring Gas Pool (Pool Code 97572). The Golden Lane-Bone Spring Gas Pool was discovered by the Yates Petroleum Corporation Temperate BEC Federal Well No. 1 (**API** No. 30-015-34339) located in Lot 13 of Section 6, Township 21 South, Range 29 East, NMPM, which was completed in the Bone Spring formation on July 30, 2006. The top of the perforations is at 7,772 feet.
- (3) There is need for the creation of a new pool in Chaves County, New Mexico for the production of gas from the Wolfcamp formation, bearing the designation of Lake Arthur-Wolfcamp Gas Pool (**Pool** Code 97574), The Lake Arthur-Wolfcamp Gas Pool was discovered by the Parallel Petroleum Corporation Dash for Cash Well No. 1 (API No. 30-005-63785) located in Unit D of Section 4, Township 15 South, Range 26

East, NMPM, which was completed in the Wolfcamp formation on September 20, 2006. The top of the perforations is at 5,570 feet.

- (4) There is need for the creation of a new pool in Eddy County, New Mexico for the production of gas from the Upper Pennsylvanian formation, bearing the designation of Little AAA Tank-Upper Pennsylvanian Gas Pool (**Pool Code** 97576). The Little AAA Tank-Upper Pennsylvanian Gas Pool was discovered by the Cimarex Energy Company of Colorado Taos Federal Well No. 1 (**API No.** 30-015-34520) located in Lot 4 of Section 31, Township 24 South, Range 27 East, NMPM, which was completed in the Upper Pennsylvanian formation on September 26, 2006. The top of the perforations is at 10,356 feet.
- (5) There is need for the creation of a new pool in Eddy County, New Mexico for the production of oil from the Wolfcamp formation, bearing the designation of Lost Tank-Wolfcamp Pool (**Pool Code** 97573). The Lost Tank-Wolfcamp Pool was discovered by the Pogo Producing Company Lost Tank 4 Federal Well No. 20 (**API No. 30-015-34918**) located in Unit H of Section 4, Township 22 South, Range 31 East, NMPM, which was completed in the Wolfcamp formation on November 23, 2006. The top of the perforations is at 12,104 feet.
- (6) There is need for the creation of a new pool in Eddy County, New Mexico for the production of oil from the Abo formation, bearing the designation of Pavo Mesa-Abo Pool (**Pool Code** 97575). The Pavo Mesa-Abo Pool was discovered by the Cimarex Energy Company of Colorado Bear Bryant 31 Federal Well No, 1 (**API** No. **30-015-34906**) located in Unit L of Section 31, Township 16 South, Range 29 East, NMPM, which was completed in the Abo formation on October 1, 2006. The top of the perforations is at 7,030 feet.
- (7) There is need for extensions to the Chosa Draw-Morrow Gas Pool, the Collins Ranch-Wolfcamp Gas Pool, the Cottonwood Creek-Wolfcamp Gas Pool, the Dublin Ranch-Atoka Gas Pool, the Four Mile Draw-Wolfcamp Gas Pool, the Happy Valley-Morrow Gas Pool, the Horseshoe Bend-Morrow Gas Pool, the North Illinois Camp-Morrow Gas Pool, the Loco Hills-Glorieta-Yeso Pool, the North Loving-Atoka Gas Pool, the West Lusk-Morrow Gas Pool, the West Malaga-Morrow Gas Pool, the South Millman-Morrow Gas Pool, the Otis-Atoka Gas Pool, the East Pierce Crossing-Bone Spring Pool, the Revelation-Atoka Gas Pool, the West Salt Draw-Morrow Gas Pool, and the North Seven Rivers-Glorieta-Yeso Pool, all in Eddy County, New Mexico, the West Cottonwood Creek-Wolfcamp Gas Pool in Chaves and Eddy Counties, New Mexico, and the South Greenfield-Wolfcamp Gas Pool in Chaves County, New Mexico.

#### IT IS FURTHER ORDERED THAT:

- Pursuant to Section 70-2-18, NMSA, 1978, an operator of any well that, by virtue of any of the above pool extensions, is subject to pool rules providing for spacing or proration units larger than the one presently dedicated thereto, shall have 60 days from the effective date of this order to file Form C-102 dedicating a standard unit for the pool to that well or to obtain a non-standard unit approved by the Division. Pending such compliance, the well shall receive a maximum allowable in the same proportion to a standard allowable for the pool that the acreage dedicated to the well bears to a standard unit for the pool. Failure to file Form C-102 dedicating a standard unit to the well or to obtain a non-standard unit approved by the Division within that 60day period shall subject the well to cancellation of allowable.
- The effective date of this order and all creations and extensions included herein shall be April 1, 2007.
- Jurisdiction of this case is retained for the entry of such further orders as the Division may deem necessary.
