ORDER OF THE DIVISION

BY THE DIVISION:

This case came on for hearing at 8:15 a.m. on May 24, 2007, at Santa Fe, New Mexico, before Examiner William V. Jones.

NOW, on this 7th day of June, 2007, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner,

FINDS THAT:

- (1) Due public notice has been given, and the Division has jurisdiction of this case and its subject matter.
- (2) There is need for the extension of the West Bravo Dome Carbon Dioxide Gas Pool in Harding County, New Mexico.
- (3) The effective date of this order and all extensions included herein should be June 1, 2007.

IT IS THEREFORE ORDERED THAT:

- (a) The West Bravo Dome Carbon Dioxide Gas Pool (**Pool Code 96387**) in Harding County, New Mexico is hereby extended to include:

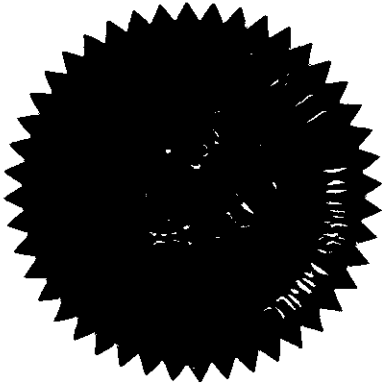
IT IS FURTHER ORDERED THAT:

(1) Pursuant to Section 70-2-18, NMSA, 1978, an operator of any well that, by virtue of any of the above pool extensions, is subject to pool rules providing for spacing or proration units larger than the one presently dedicated thereto, shall have 60 days from the effective date of this order to file Form C-102 dedicating a standard unit for the pool to that well or to obtain a non-standard unit approved by the Division. Pending such compliance, the well shall receive a maximum allowable in the same proportion to a standard allowable for the pool that the acreage dedicated to the well bears to a standard unit for the pool. Failure to file Form C-102 dedicating a standard unit to the well or to obtain a non-standard unit approved by the Division within that 60-day period shall subject the well to cancellation of allowable.

(2) The effective date of this order and all extensions included herein shall be June 1, 2007.

(3) Jurisdiction is hereby retained for the entry of such further orders as the Division may deem necessary.
