Reference is made to your application received on August 20, 2014.

You have requested to simultaneously dedicate the N/2 NE/4 of Section 36, Township 17 South, Range 34 East in Lea County, New Mexico, in the Vacuum; Abo, North (Pool Code 61760), Vacuum; Upper Penn (Pool Code 62320), and Vacuum; Wolfcamp (Pool Code 62340)

to the above-described two wells. Applicable spacing rules for all three pools allow only one oil well per standard 80-acre unit.

Your application has been duly filed under the provisions of Division Rules 15.13 19.15.15.11C NMAC and 19.15.4.12 A (2) NMAC.
