12/16/19 - MIRU and POOH with production equipment. NU BOP. Set a 5-1/2" CIBP at 4426', tagged. Circulated 105 bbls water with 27 sx salt water gel as plugging mud. Pressure tested to 500 psi with no leak off or communication at surface. Spotted 25 sx Class "C" cement on top of CIBP to 4179' calc TOC. WOC to tag.
 12/17/19 - Tagged TOC at 4163'. Perforated at 2232'. Pressure tested to 500 psi with no leak off or communication at surface. Spotted a 25 sx Class "C" cement plug from 2232'-2035' calc TOC. WOC to tag. Tagged TOC at 2079'. Perforated at 1190'. Established circulation up 8-5/8" casing to surface with 11 bbls water. Circulated inside/outside cement plug with 35 sx Class "C" cement up 8-5/8" casing from 1201'-1079' calc TOC.
 12/18/19 - Tagged TOC at 1022'. Perforated at 100'. Established injection rate into perms with full circulation up 8-5/8" casing. Circulated 35 sx Class "C" cement down 5-1/2" and up 8-5/8" casing from 100' up to surface. Topped off with cement.
 2/17/20 - Cut off wellhead and installed dry hole marker. Cut off anchors and cleaned location. **WELL IS PLUGGED AND ABANDONED.**
