- 2) POOH laying down rods and pump. ND WH, NU 3K manual BOP. Unseat 5-1/2" x 2-7/8" tbg anchor and POOH laying down 2-7/8" 6.5# J-55 tbg.
- 3) MIRU WL lubricators. RIH w/ 5.5" gauge ring & junk basket. Contact the engineer Joe Black (432-301-8312) if any tight spots exist. POOH w/ 5.5" gauge ring & junk basket (5.5" drift is 4.89").
- 4) RIH WL w/ 5.5" CIBP and dump bailer to 6,150'. Set CIBP and dump 35' cement over plug. WOC and Tag at least 6,115'. POOH & RDMO WL.
- 5) RIH 2-3/8" workstring, Load csg w/ 2% KCl with biocide and pressure test csg to 500 psi for 30 minutes. Notify BLM of result. POOH w/ 2-3/8" workstring.
