On 12-19-76 spudded 24" hole w/ rat hole machine for conductor pipe. Reached TD of 100' 12-20-76 and set 16" casing at 100' with 7 cubic yards cement. Moran Brothers spudded 12 1/4" hole 7:15 AM 12-30-76. Reached TD of 1512 1-7-77. Run 9 5/8" casing and set at 1512' with 550 sx Halliburton Light Cement containing 9# st/sx, 1/4# flocele/sx, 3# gilsonite/sx followed by 225 sx. Class "C" cement w/ 2% CACL. Plug down 11:05 PM 1-7-77. Circulate 44 sx. WOC 18 hrs. Test casing w/ 1500 # 30 min. Test OK. Reduce Hole to 7 7/8" and resume drilling.
