Well was spudded at 6pm March 3, 1980.

On March 5, 1980 we ran:

36 joints, 8 5/8", 24#, K-55, short thread and collar, 1456', cemented with 850 sacks, Halliburton Lite, 2% calcium chloride, 13.6 PPG. 150 sacks, Class "H", 3% calcium chloride, 16.5 PPG. Circulated 100 barrels of good cement. We pressure tested to 1000# for 15 minutes, thirteen hours after plug, and the casing held OK.
