Casing consisting of 27 joints of 8-5/8", 24#/ft., K-55, ST & D casing was set at 1100' with 650 sx, Class C, 2% CC, 12.7# cement plus 150 sx Class C, 2% CC, 14.8# cement. Total slurry was 248 bbl. and was displaced with 65 bbl. of water after circulating 198 bbl. good cement. Good circulation throughout job.
