Moved in service unit 12-29-84. Ran swab unit and recovered 100 BW. Perforated intervals 2256'-2276'. Ran and set packer at 2214'. Stimulated well with 1000 gallons 7 1/2% HCL acid plus additives and 90 ball sealers. Rigged down and moved out service unit. Flow tested through a separator for 1 1/4 hours at an average of 240 MCFD.
