On 12-3-84 CO2 in action Righ 16 spudded a 12½" hole and drilled to a total depth of 640 ft. On 12-4-84 ran and set 9-5/8 casing at 728 ft. Cemented with 390 sacks Class h cement with additives. Plugged down at 11:45pm on 12-4-84. Circulated 100 sacks Class H cement to reserve pit. Wait on cement for 12 hours. On 12-8-84 ran 7" casing and set at 2873 ft. Cemented with 1300 sacks Class h cement with additives. Circulated 290 sacks cement to reserve pit. Plugged down at 6:15am on 12-9-84. Rig released 9:15 am on 12-9-84.
