Dear Justin:

On January 30 you wrote us regarding the Paul Lawlis No. 1 Lee in SE SW 32-6N-30E, Quay County, N. M., which at the time of your letter was shut down at 130 feet, waiting on rotary tools.

We note from your February 7 scout report that the well is still at that stage. However, we have not yet been furnished with a one-well bond by Mr. Lawlis, and unless the bond is now in process of being made, it seems to me that you should actually issue a shut-down order on the job. Quite possibly there are no signs of a resumption of drilling, but there should be no reason why Lawlis is unable to submit the required bond.

I will appreciate your advising me if there is any information you have on this well, or, if you are in contact with a representative of the operator, perhaps you can find out why no bond has been furnished.
