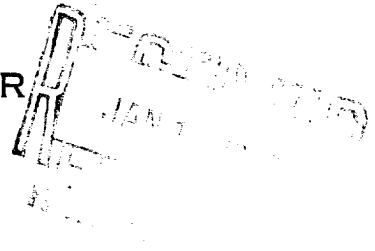

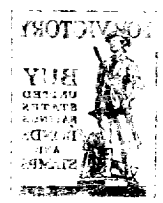

DETAILS OF WORK

At 7:00 P.M. January 9, 1945, 72 hours will have elapsed since setting 13" casing at 1084' and cementing to the surface with 500 sacks of cement.

At this time, we plan to test this casing shut-off in the following manner:

Build up 1000# pressure and hold for 30 minutes. If the test is o.k. drill plug, again build up 1000# pressure and hold for 30 minutes. If this too is o.k. drilling will be resumed.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
