Hole has been drilled to depth of 6128' and is bottomed in schist. No shows of oil and/or gas have been encountered. We therefore propose to abandon the hole and will proceed as follows:

Set a cement plug below salt at 3112'; set cement plug at 1869' on top of salt; set cement plug in bottom of surface casing at 331'; set regulation marker at surface, in 13-3/8" casing; clear location site and leave as nearly in original condition as possible.
