On my last inspection trip of the above captioned location, I was unable to locate any one who could give me any definite information as to the future intentions of this well.

Our files are noticably lacking of any reports which are due us concerning your activities in regard to this operation. We are therefore at this time requesting that we be supplied with forms C-103 for each casing operation accomplished, each drill stem tests, cementing job or any other operation other than normal operation of drilling.

We would also like to have the samples and a statement as to total depth and the formation or type of rock in which you are drilling.

Also, it is my understanding that you have not had any activity at this location for at least 60 days. I would like to call your attention to paragraph C Rule 202, of the current Rules and Regulations which states that when drilling operations have been suspended for 60 days, the well shall be plugged and abandoned unless a permit for temporary abandonment shall be obtained from the Commission.

If it is not your intention to abandon this well it will be necessary that we receive from you a written application for temporary abandonment in which you should state your precise reason for applying for temporary abandonment.
