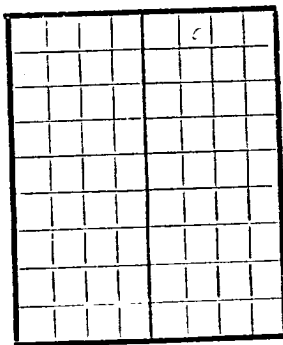

Additional information: I intend to run one or two strings of surface pipe to shut off water. I intend to run 7" to the first hard lime below 2800' and cement with 35 sacks. If commercial production is encountered we will work out a casing program satisfactory to the commission on this well, two staging if necessary.
