Dear Sir:

This will acknowledge receipt of your letter of March 17, 1954, wherein you request information for final reports on your San Miguel County wells, McCune No. 1 and Roberts' No. 1 and your De Baca County Myrick No. 1.

I regret to say that on the Newton R. Roberts #1 McCune well at NW/4 NW/4 Section 22, Township 11 North, Range 13 East, at San Miguel County, our files are lacking the C-103 form, Report on Result of Plugging Well and also the C-105 form, Well Record. The last we have on this well is a form C-102, Notice of Intention to Plug Well, submitted by Mr. Fred L. Baker on July 20, 1952 and approved by me on July 21, 1952, giving a detailed account of your proposed plugging program. We cannot close this file until a correct account on the result of plugging is submitted and approved and a well record also is at hand. The latter should have at least a reasonably accurate driller's log and formation tops and if electric logs are available they will be received, strictly for the record. Following receipt of these final reports an inspector from this office usually visits the lease to verify the reported conditions in which the location is left, in the interest of the landowner.

On the Newton R. Roberts #1 Aaron well at SW/4 SW/4 Section 14, Township 11 North, Range 15 East of San Miguel County, we have a C-103, Report on Conversion to Water Well, dated November 21, 1952 and submitted by Mr. Fred L. Baker. This report also includes a statement by Mr. I. V. Lucero, the landowner assuming full responsibility for the eventual plugging of this well left for him as a water well. This is all very proper but same has been held by us and not approved pending receipt of a C-105 and a final check of the lease, mud pits, well markers, etc.

The file on the Myrick well is complete and in order, with a final C-103 on plugging submitted and approved and a C-105 also.

Please find enclosed some blank C-103 and C-105 forms for your convenience.

I hereby advise you that the final reports on plugging shall not be approved until the leases are restored to their original condition, i.e. all mud pits levelled and location cleaned of all junk; and a regulation marker is placed over or near the well bore. Same should have the operator's name, lease name, well number, section, township, range, and county in that order on a metal plate stamped or put on with a welder's bead. A regulation marker is a 4 inch, or larger pipe set in the upper part of the top cement plug at the surface and extending at least four feet above the ground level. This may be set in concrete beside the well bore.
