ALL WENT WAS A DRY HOLE. THE FOLLOWING IS THE METHOD USED:

1. Sack Plug at 500'.

2. Sack of Cement at 200'.

Waited twelve hours and run pipe in the hole. Found top of cement at 200'. Then sack plug in top of surface pipe. 4" pipe put in the top plug - sticking up in the air.
