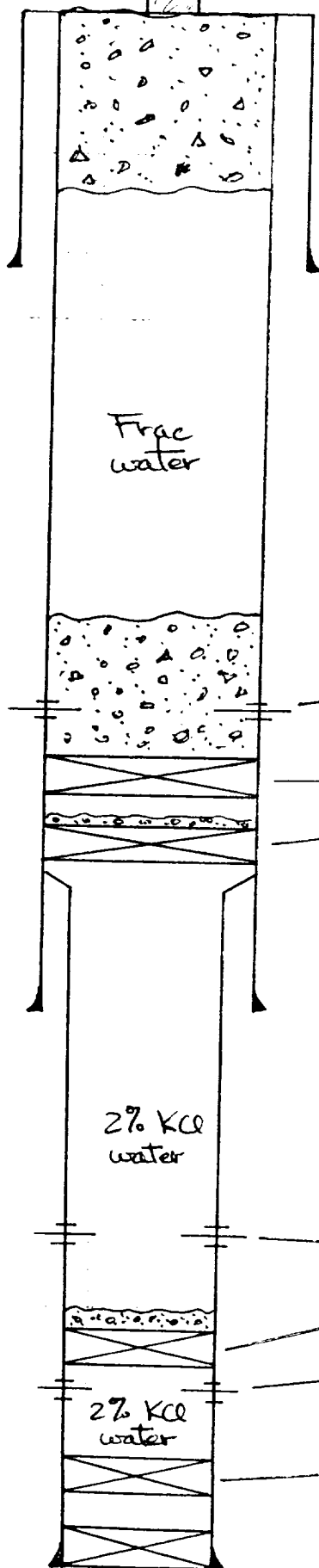
- 1) Move in and rig up pulling unit. Nipple down wellhead.

- 3) M & P 125 sxs Class "A" neat at 15.6 ppg and spot 342' balance plug from 6380- 6038'. POH to 300'. M & P 110 sxs Class "A" neat at 15.6 ppg and spot 300' balance plug to surface. Release pulling unit.
- 4) Nipple down all wellhead equipment. Install dry hole marker. Clean location. (See attached schematic)
