Western cemented with 1575 sacks 65/35 poz mix cement with 6% gel and 5# Gilsonite, followed with 200 sacks Class"H" with 1/4# Celloseal. Plug down at 2:45 A.M. 10/25/81 with 2400# pressure. Circulated 130 sacks cement to surface. N. U. BOP's and Rotary Head and test casing and BOP's to 1500# for 1/2 hr. Now drilling 6 3/4" air drilled hole.

Moved in and rigged up Y.W. Drilling Company Rig #4. Spudded 14 3/4" surface hole at 4:30 P.M. 10/9/81. Drilled 14 3/4" hole to 376'. Ran 10 3/4" 40.5# K55 ST&C casing to 374'. Western cemented 10 3/4" casing with 450 sacks Class "H" cement with 2% CaCl and 1/4# Celloflake, Plug down at 7:30 P.M. 10/10/81 with 1000#, circulate 135 sacks cement to surface. Wait on cement and installed 10" 3000# x 9 5/8" SOW casing head and 10" 3000# double ram BOP, Tested casing and BOP's to 500# for 1/2 hr. at 1:30 P.M. 10/11/81. Now drilling 9 7/8" hole.
