1/27/86:

Rig up SOS well service. Blow well down. Try to unseat pump. Pump would not unseat. Strip rods out of tubing.

1/28/86:

Finish stripping rods out of tubing. Rig up Howco cement retainer. Trip in hole with tubing and retainer. Set retainer at 5007.86' KB. Load casing with 55 bbls water. Pump 40 sks (47.2 CF) of cement displacing it to retainer leaving 1 bbl (64.5 ft) of cement on top of retainer. Lay down 146 joints of tubing. Set a (10 sks, 11.8 CF) cement plug from 255' up to 120' KB. Trip out of hole with tubing. Nipple down BOP and well head. Weld a steel plate on top of 4 1/2" casing.
