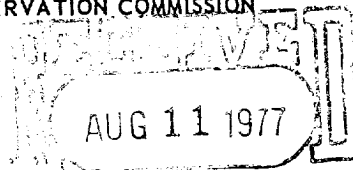

New Mexico 87825, said well being drilled to test for hydrocarbons and/or carbon dioxide gas and described as the Major-SFPRR No. 1, being located 2100 feet from the East line and 750 feet from the South line of Section 27, Township 4 North, Range 6 West, NMPM, Socorro County, New Mexico.

3. That said well was drilled to a total depth of 4690 feet, and that casing has been set and cemented as follows:
